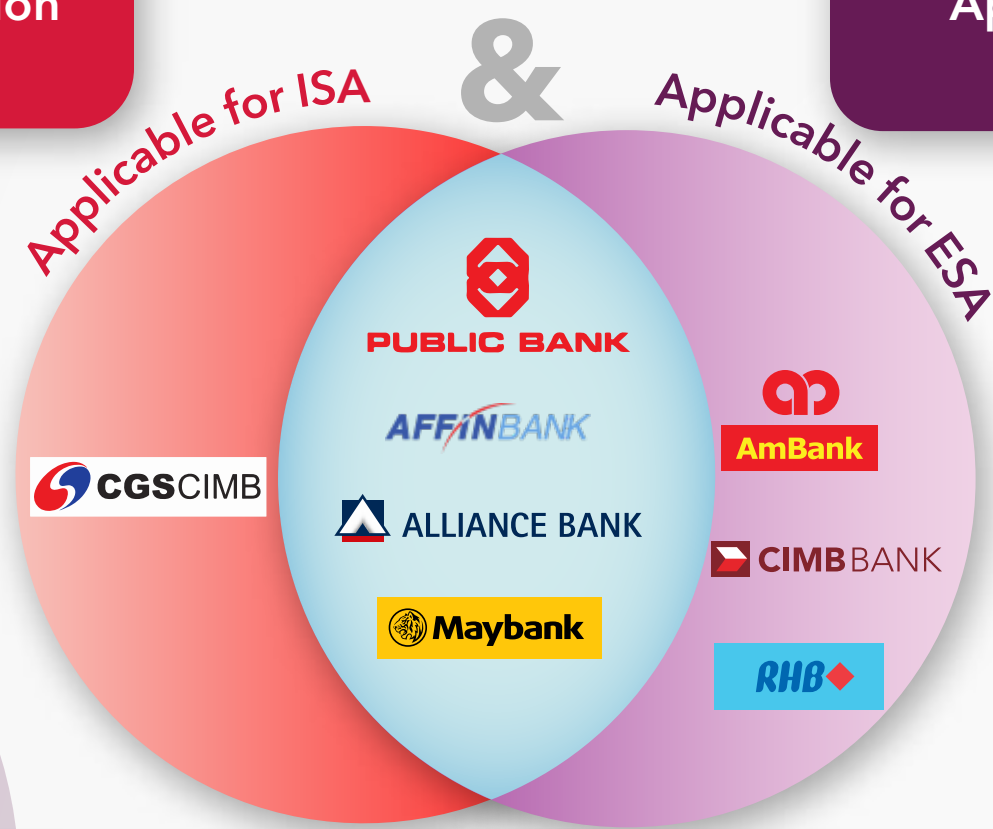


# HOW TO APPLY FOR IPO SHARES?

You can submit via **ORDINARY MAIL** or drop it into the **DROP-IN BOXES** @ Tricolor Customer Service:

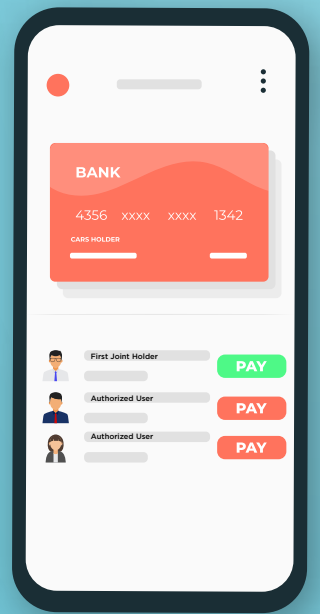

**For Joint Bank Account holders,** please ensure that your application details match with the CDS Account details indicated in your application.

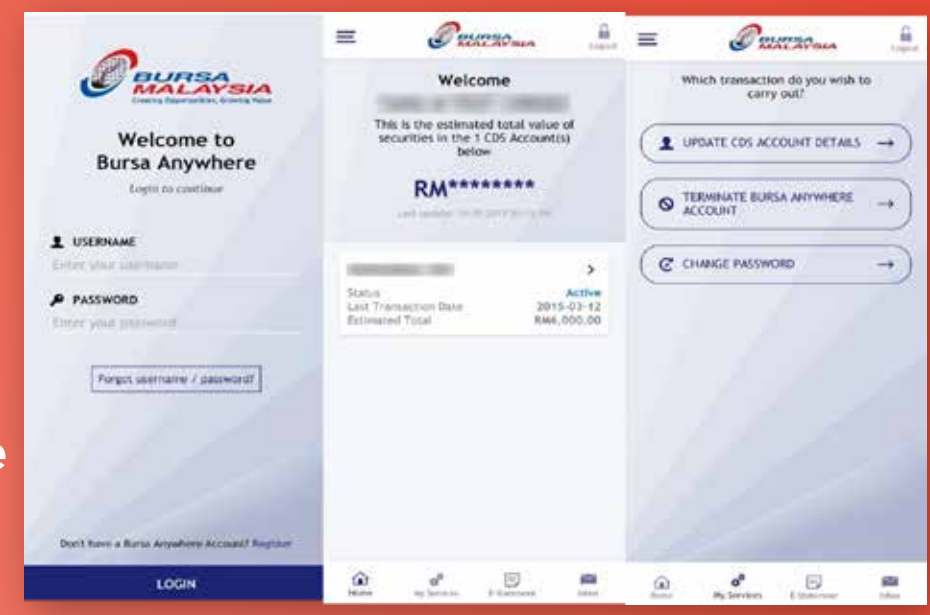
**IF I APPLY VIA ONLINE, CAN I USE JOINT BANK ACCOUNT TO PAY?**

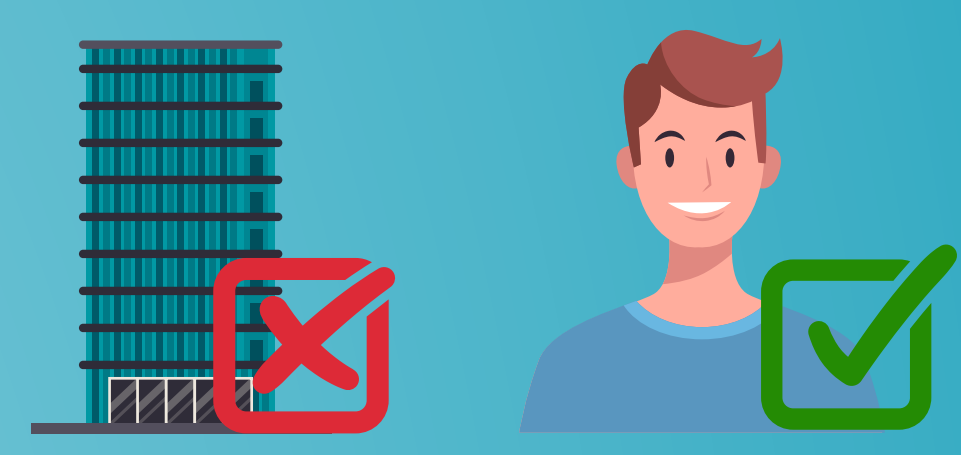
**MUST I HAVE A CDS ACCOUNT?**

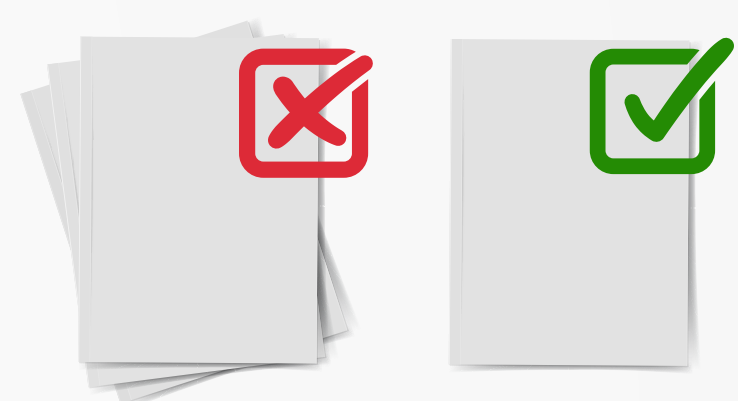
**NO, only CDS Account in your name is allowed**



**CAN I SUBMIT MORE THAN ONE SHARE APPLICATION?**

**Multiple submission is NOT ALLOWED**

and is an offense under the Capital Markets & Services Act, 2007 which prescribes severe penalties for the offence



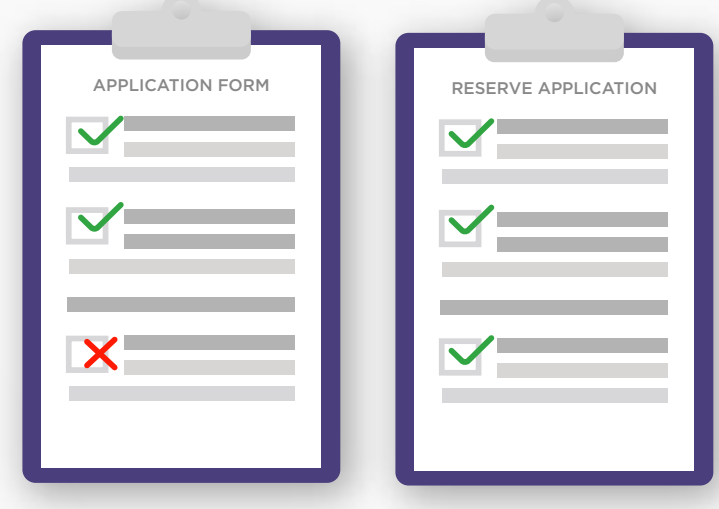
